1230 Western Avenue

As mentioned previously, at our September meeting Collegiate Development Group, represented by Hershberg & Hershberg, presented a proposal to develop a five-story structure at 1230 Western Avenue. The site is currently occupied by the Days Inn, and was formerly occupied by TraveLodge and Dunkin' Donuts. The primary use of the new building would be for student housing, with 420 bedrooms, 172 below-grade parking spaces, and some retail space.

National Grid gas line replacement

National Grid now has the required permits from NYS DOT, and replacement of gas lines on streets off the north side of Western Avenue should begin in December. Weather permitting, construction will continue through the winter and all of the gas lines should be installed by spring 2021. AGI will be the subcontractor.
