**Whereas**, the plans as submitted to the proper authorities call for a new right-of-way and the acquisition of certain lands owned by me (us), and

**Whereas**, the Highway Law compels the acquisition of this land by the Board of Supervisors of Albany County, and the Board of Supervisors has signified its intention of securing such lands, either by agreement or condemnation, and

**Whereas**, no agreement has been entered into between the said Board of Supervisors and me (us) as to the amount to be paid for such lands.

**Now, Therefore**, in consideration of one dollar (\$1.00) in hand paid at or before the execution of these presents, { I \_\_\_\_\_ ALBANY COUNTRY CLUB \_\_\_\_\_

interested in the parcels of lands hereafter described which are to be acquired for such highway improvement, and in further consideration of an agreement between the representatives of the Board of Supervisors of Albany County and me (us) that if no satisfactory price for such lands can be agreed upon between the said Board of Supervisors and me (us) for such lands that it, the Board of Supervisors, will acquire such lands as provided in the Highway and Condemnation Laws.

do consent and agree that the authorities and the employees of the County of Albany and the Contractor to whom the contract may be let for the improvement of said highway, together with his workmen and employees, may enter upon the premises herein described, for the purpose of the construction or reconstruction of said highway, without becoming or being held liable for trespass, or for any damage whatsoever, to me (us), and I (we) do hereby waive any and all claims for such entry and occupation.

The purpose of this agreement being that, in order to expedite construction or reconstruction of this highway, the Contractor, his agent or employee, and the Albany County Highway Department, its agents or employees, may occupy the said described land to the full extent that they might had the land been acquired and the title passed to the County of Albany.
