MCKOWN, ANNA J. BLESSING, WILLIAM J. MCKOWN and ELIZABETH W. MCKOWN wife of said William J. MCKOWN
all of the City of Albany County of Albany and State of New York, parties of the first part,
and WILLIAM H. WITBECK of the County of Albany and State of New York, party of the second part.
WHEREAS, The said William J. Mckown, deceased died in the County of Oneida, leaving a last will
and testament which was duly admitted to probate, wherein and whereby the above named Kate

the parties of the first part by the party of the second part, have granted, bargained, sold, con-
veyed and quit-claimed, and by these presents do, for themselves, their heirs and assigns grant,
bargain sell, convey and quit-claim unto the said party of the second part and to his heirs
and assigns forever,

ALL that CERTAIN PIECE OR PARCEL OF LAND situate lying and being in the town of

Guilderland, Albany County, N.Y. TOGETHER with all and singular the hereditaments and appurtenances thereto belonging or in anywise appertaining, and the reversions and remainders, rents, issues and profits thereof.

AND all the estate, right, title and interest property possession, claim and demand, whatsoever which the said William J. McKown, deceased had in his lifetime and at the time of his death and which the said parties of the first part have by virtue of the said last Will and Testament of William J. McKown, deceased, or otherwise, of in and to the above described premises and every part and parcel thereof, with the appurtenances,

TO HAVE AND TO HOLD the said above described premises to the party of the second part, his heirs and assigns forever.

AND the said parties of the first part, for themselves and for their heirs, executors and administrators, do covenant and agree to and with the said party of the second part, his

heirs and assigns that they have not made, done, committed, executed or suffered any act or acts, thing or things whatsoever, whereby or by means whereof, the above mentioned and described premises or any part thereof or parcel thereof, now are, or at any time hereafter shall or may be impeached, charged or incumbered in any way or manner whatsoever.
