grant and convey to the said party of the second part her heirs and assigns ALL that

Between Aaron Fuller of the town of Guilderland Albany County N.Y. of the first part and Samuel Van Allen of the Town of Bethlehem Albany Co N.Y. of the second part. Witnesseth that the said party of the first part in consideration of the sum of two hundred and sixty dollars to him duly paid has sold and by these presents does grant and convey to the said party of the second part his heirs and assigns,
