In March, the guest speaker was **Town Supervisor Peter Barber**. That the storm water drainage project is moving forward was the welcome news he brought to the meeting. The project is going to take multiple years, as any "make-over" project should, but it is progressing. Recently the Town Highway Department (**Superintendent Steve Oliver**) repaired an erupting storm water pipe in the Elmwood/Parkwood alley (thanks to resident Steve Campbell's spotting the flooding and making timely calls). Another storm water-flooding problem—between Waverly and Knowles—was addressed by the Town (thanks to Josh Merlis's calls).

The guest speaker for the May meeting—May 18—will be **New York State Assembly Member Patricia Fahy**. Our assembly member has been supportive of McKownville and Guilderland. Do plan to attend. She always gives a very informative talk.

The Holt-Harris property, owned by the UAlbany Foundation, continues to be undeveloped (thankfully). SUNY Poly has re-started its regular meetings with a committee from the Association (Ellen Manning, our secretary, Janet Reilly and Dennis Mason). Loughlin Street/Sandidge Way rezoning by the City of Albany is still being opposed—a dozen or so residents (many of whom live on Warren Street but joined by **Town Supervisor Peter Barber**, County Legislator Paul Miller and others) have been very active. The re-development of four properties on Western (the vacant house near City Line Inn, the McKownville fire house, the Best Western motel and the former Getty station site) have not yet begun their planned re-construction.
