A law regulating parking at
Stuyvesant Plaza Shopping Center.

Stuyesant Plaza Shopping Center. Statement of legislative intent. WHEREAS, Stuyvesant Plaza, Inc., a domestic corporation, owns and operates a snopping center wholly situated within the Town of Guilderland at the intersection of Western Avenue and Fuller Road having one or more stores or business establishments in connection with which there is provided

ness establishments in connection with which there is provided on privately owned property near or contiguous thereto an area or areas of land totaling at least one acre in area used by the public as a means of access to and egress from said scores and business establishments and for the free parking of motor vehicles of customers and patrons of such stores and business establishments on such premises, and

such stores and business establishments on such premises, and WHEREAS, for the safety of members of the general public and for the protection of property and for the general welfere of the community it is deemed necessary to regulate, restrict and limit the stopping, standing or parking of vehicles on said shopping center premises, and WHEREAS, the owner or person in general charge of the operation and control of said premises has requested in writing the enactment of a local law so regulating the parking of motor vehicles on said premises;

NOW, THEREFORE, BE IT ENACTED by
the Town Board of the Town of Guilderland as follows:
Section 1. The parking of a motor
vehicle upon the lands and premises of
the shopping center known as Stuyvesant
Plaza at Fuller Road and Western Turnpike in the Town of Guilderland, including the roadways, fire lanes, pedestrian
walks and all other areas of said premises and the lands and premises contiguous and appurtenant thereto, excepting
within those areas marked and defined
by road markings as parking areas and
except as herein otherwise provided, is
prohibited.

within those areas marked and defined by road markings as parking areas and except as herein otherwise provided, is prehibited.

Section 2. The foregoing prohibition shall not apply to commercial vehicles parking at loading docks or rear service entrances to stores or business establishments in said shopping center while actively engaged in the delivery of merchandise, supplies or other material or in the rendering of services to such store or business establishment.

Section 3. Any violation of the provisions of this local law shall subject such violator to a civil penalty not to exceed Ten Dollars (\$10.00) for the first violation and not to exceed Twenty Dollars (\$20.00) for each subsequent violation and shall further subject such violator to such further penalties as may be provided by the Vehicle and Traffic Law of the State of New York; provided, however, that a charge of violation may be disposed of by tendering to the town clerk of the Town of Guilderland a notice of violation served upon such violator as herein provided together with the sum of Two Dollars (\$2.00) within ten (10) days of the date of such notice. A notice of violation hereunder may be served upon such violator by placing such notice on the windshield of the motor vehicle in violation and may be so served by the owner or operator of said shopping center or by any agent, servant or employee thereof or by any officer or employee of the Town of Cuiderland.

Section 5. This law shall take effect immediately.
