Board of Directors Meeting

April 5, 1973

The meeting began at 8:45 p.m. in Christ Lutheran Church. Minutes of the previous meetings were distributed.

The main agenda items for this meeting were:

1. preparation for the annual meeting to be held on Monday, April 30, 1973 at 8:00 p.m. in Christ Lutheran Church. Mr. Joseph Rose, of the Guilderland Planning Board will be the speaker. Mr. Purdy was asked to contact him as to his availability. (This was confirmed.)
2. Election of officers and Board members for the forthcoming year. The nominations committee would present the names for election.

Mr. Prytherch presented a tentative slate of nominations indicating that the people listed had shown interest in town activities in the past year and would be good candidates. He would contact these people prior to the meeting to see if they would be interested in serving on the Board. (See list attached.)

Mr. Purdy reviewed the By-laws pertaining to elections and membership. He also indicated that provisions would be made for 'write-in' nominations.

Items to be discussed at the annual meeting could include garbage collection, the disposition of the property of the McKownville Reservoir, if and when the turnover to the Westmere Water District occurs, and the water issue itself.

Mention was made of the fact that a public hearing would be held on April 10 relating to Local Law #2 (zoning). It was suggested that members of the Zoning Committee attend the meeting in order to obtain clarification on the matter. Mr. Prytherch and Mr. Johnston indicated that they would try to attend.

Mr. Purdy read a letter of response from Commissioner Diamond (Env. Conserv.) and President Benezet (SUNYA) regarding the question of pollution by SUNYA which was brought to their attention earlier. Both indicated that positive steps were being taken to eliminate this situation.

Mr. Behn spoke of other items including refuse collection, re-cycling, and state aid to education.
