- 3. THE HEARING. John Shea(31 Norwood St.) has been doing a brilliant job representing the McKownville Improvement Association at the EnCon Hearings. His cross-examination of Pyramid's testimony has blown big holes in their claims. The cross-examination this week will be on water and soils. Then there will be a two week recess, followed by cross-examination of Pyramid's witnesses on air, traffic, biology, alternative sites, design, and solid waste. BUT we need a larger cheering section! The Hearing is from 9:30 to 5 PM,daily, with lunch from 1 to 2, at the Ramada Inn on the second floor in the Squire Meeting Room.
