Horan Plans Crossgates Opposition

GUILDERLAND - Virginia Horan, the first Democrat to

win a Town Board seat in Guil-

derland since about 1870, yesterday said her first proposal to the board will be to rezone the Crossgates Mall parcel for resi-

dential use.

The Guilderland Democrats' campaign to oppose the \$85 million mall's construction by the Pyramid Crossgates Co. gave

the incumbent Republicans the slimmest election pluralities they've had in many elections. Unofficial results from Tuesday's election put Horan ahead of the other three candidates, but the spread among the four

was only 334 votes, with the two Republicans in the middle. The two candidates with the most votes will take board

seats in January. Both sides agree Horan has a seat, but the Democrats also hope official

Horan unofficially received 4.757 votes and John Smircich, a Republican newcomer, received 4,539. Republican Pauline Porter, seeking re-election, received 4,486 votes, and Pearl Kurland, the other Democratic candidate, received 4,423. The Democrats were gratified

and the Republicans were disappointed with election results that gave Town Supervisor Carl J. Walters a plurality of only 607 votes over Don Berger. Walters received 5,013 votes to Berger's 4,406.

Martin's challenge, 5,737 to Republican Town Clerk Jane Springer was re-elected by a margin of 5,273 to 4,004 for Maria Gilberti, a former deputy

town clerk in Rotterdam. Herman VanBuren, town highway superintendent, continues the longest town tenure with 5,205 votes to 4,023 for Democrat Charles Arcolano.

The Democrats gained a Guil-

derland seat in the County Legislature with Anne Gaffney's defeat of Donald Munn, the incumbent Republican in the 33rd District, where the Crossgates Mall is proposed. Gaffney received 1,938 votes to 1,583 for Munn, according to unofficial Board of Elections tallies.

Democrat Thomas Callaghan, the 31st District incumbent, retained his seat with 1,535 votes from three lines; Alphonse Diana, the Republican candidate, received 1,141.
