Commissioner of the state Department of Environmental Conservation has asked Town Supervisor Carl J. Walters to inform him by Friday whether town officials plan an alternative traffic arrangement to the

tive traffic arrangement to the widening of Western Avenue proposed by Pyramid Crossgates Co. for its \$85-million Crossgates mall.

In a letter Robert Flacke sent Walters Friday, the state agency chief asked whether the town

has developed plans addressing the "compatibility" between fu-

ture commercial growth and Western Avenue traffic levels, and if so, what are the plans.

He also asked Walters for

speculation on potential resi-

dential and commercial growth along Western, with or without Crossgates. Finally, he asked the town supervisor whether the

town has proposed a substitute for Alternate 4. Alternate 4 calls for construction of a new, fourlane bridge carrying Western Avenue over the Thruway adja-

Avenue over the Inruway adja-cent to the existing Western Av-enue bridge, as well as widening of Western, construction of a county road along the western edge of the 150-store mall and construction of a ramp from Washington Avenue Extension to the proposed county road. Flacke said Walters must re-

spond by Friday, because by April 28 Flacke has to decide whether to reopen hearings on Crossgates, ask for additional information and least the record information or close the record. If he chooses the last alternative, Flacke will have to make a decision on 11 environmental

decision on 11 environmental permits the developer needs before approaching the town Zoning Board of Appeals for Special Use Permits for setback and highway-widening variances.

Longtime Crossgates opponent Lindsay Childs unveiled Flacke's letter during a Democratic Committee forum at the Tom Sawyer Motor Inn last night. The forum was one of four aimed at developing a Town
